THIS YEAR, OVER 30,000 PEOPLE IN AND AROUND THE RICHMOND, VA AREA WERE ENTERTAINED BY TWO REPERTORY PRODUCTIONS AS WELL AS FULL LENGTH PRODUCTIONS OF "THE NUTCRACKER" AND "SWAN LAKE." TWO ADDITIONAL REPERTORY PRODUCTIONS WERE POSTPONED DUE TO THE COVID-19 PANDEMIC. RICHMOND BALLET ALSO COMPLETED TOURS TO VARIOUS VIRGINIA SCHOOLS AND LOCALITIES THROUGHOUT THE COMMONWEALTH, REACHING OVER 20,000 STUDENTS.
